The 14<sup>th</sup> meeting of the SLC was convened on 13.10.2022 at 11.30 a.m. in the Office of the Prl. Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, Guntur to consider various proposals of Wood Based Industries for change of ownership, relocations and other related matters as per Andhra Pradesh Wood Based Industries (Establishment and Regulation) Rules, 2018.

#### **4. Fresh license** for lapsed licenses

The Proposals in respect of the following (2) Sawmills placed before the SLC have been examined by members.

For SI. no.1, M/s Trinity Boards, Visakhapatnam, it was agreed to issue fresh license, provided the sawmill is relocated from its present place of establishment to another place, beyond 5 km. distance from the nearest forest boundary.

For SI. no.2, Nageswara Rao Saw Mill, Guntur, as per the information provided by the CCF, Guntur and DFO, Guntur it is not a case of lapsed sawmill license. The Sawmill owner had paid the required fee in time. The license has neither lapsed nor cancelled. The Sawmill license has not been renewed since 2018 with a reason that there is discrepancy in the location of the Sawmill shown in the licenses renewed from time to time. Therefore, the DFO, Nellore may cause inquiry and take action to renew the license when it is found that everything is in order as he was already authorized renew the licenses of the Wood Based Industries. In case of violation to the provisions of Act and Rules, he may take action as per Rule 14 of A.P. Wood Based Industries (Establishment and Regulation) Rules, 2018.

#### 5. Update on (56) Sawmills established post 30.10.2002

As per the update placed before the SLC on these (56) Saw Mills established post 30.10.2002, only 13 applications have been received from the Sawmill owners seeking permission for renewal of their sawmills. For the balance 43 Sawmills no application has been received for more than 2 years. The members of the committee decided to wait for the next SLC to take a call whether to close this issue once for all, without entertaining any further proposals.

#### 6. Update on Wood Balance Study.

- i. The Trees Outside Forests (ToF) assessment conducted by the IT wing wing was presented to the SLC. The studyy was carried out by updating the 25% inventory points for the previous TOF., to arrive at total growing stock and number of trees outside Forest areas.
- ii. The total growing stock of the state is estimated to be at 79.83 million cubic meters and the total number of stems is estimated to be at 183.64 million
- iii. Species like Mango, Vepa, Asian Palm and coconut were the major contributors to Trees outside Forests.
- iv. The SLC agreed to constitute a sub-committee comprising of PCCF (IT & Res), PCCF (Production), CCF Rajahmundry, CCF Guntur and a Representative from the wood based industries to analyse the data of the

TOF and assess the wood demand of existing saw mills in the state. The sub-committee shall come out with a clear picture regarding the annual availability of the wood in the state and with recommendations regarding permitting the additional machinery for existing saw mills/permitting new saw mills in the state, within a period of three months.

7. The permissions granted by the PCCF & HoFF and Chairman of the SLC in the months of March, April, and May 2022 under Rule 5(5) of WBI(Establishment and Regulation) Rules, 2018, as per the decision taken in the 13<sup>th</sup> SLC, have been ratified.

#### 8. Other items:

1. <u>M/s Kanakadurga Saw-mill, Busarajupalle, Buttayagudem</u> (M), Eluru.

The SLC opined that a factual report may be called from the Divisional Forest Officer, Eluru and Chief Conservator of Forests, Rajahmundry on this lapsed sawmill for further action.

# 2. <u>Authorizing the Divisional Forest Officers (T) for renewal of</u> licenses:

The SLC resolved to authorize the Licensing Authorities/ DFOs to renew the Licenses of the existing Sawmills, beyond  $31^{st}$  December, 2022, under rule 10 (5).

The meeting concluded with the Prl. Chief Conservator of Forests & Head of Forest Force thanking all the members for participating and providing valuable inputs.
